Alabama Workers Compensation Law And

Workers' Compensation. The Workers' Compensation Division is responsible for the administration of the Alabama Workers' Compensation Law to ensure proper payment of benefits to employees injured on the job and encourage safety in the work place. The main function of the Division is to ensure proper payment of compensation benefits along with necessary medical attention to employees injured on the job or their dependents in case of death.

Alabama Department of Labor | Workers' Compensation

Workers' compensation in Alabama consists of two parts: compensation for medical bills arising out of a work-related injury, and wage-replacement compensation for wages lost from time away from work.

Alabama provides wage compensation in varying amounts for varying periods of time depending on whether you are temporarily total disabled, temporarily partial disabled, permanently partially disabled, or permanently totally disabled.

Alabama state law requires most public- and private-sector employers to provide workers' compensation insurance. The law defines employers as any person or entity with five or more employees. The term "employee" applies to all full-time or part-time employees, officers of a corporation, or members of a limited liability company.

Under Alabama law, most private and public employers in the state with five or more employees must have workers' comp insurance to cover employees' workplace injuries and illnesses.

Alabama workers compensation laws state that anyone who claims a pre-existing condition was the result of a job injury is committing fraud. If an employer tries to deny you benefits in this way, you will have to prove this is not the case. Additionally, fraud is a serious violation of Alabama workers compensation laws.

Alabama worker's comp law provides two basic benefits after a workplace accident: Payment of work-related medical bills and payment of 2/3's of your average weekly wage during the time you are unable to work.

UNDER ALABAMA WORKERS' COMPENSATION LAW IF YOU ARE HURT OR INJURED AT WORK: Report any injury immediately to your supervisor, boss or employer. Check with your supervisor or employer about which doctor you should see for your work related injury.

Alabama Workers' Compensation Treatment: The employer is responsible for the payment of reasonably necessary medical treatments obtained by the injured employee during the disability. They will select the treating physician at the time of the accident.
