In order to change the name, the memorandum and articles of association of the company will undergo alterations. The approval of the members of the company by passing of a special resolution is required for this purpose.

*Company name change: how to change your company name.*

Since the change in name of the company also requires amendment in various documents of the company viz., Memorandum and Articles of Association, letter head, invoices, etc., it is advisable to pass special resolutions for alteration of respective clauses of Memorandum and Articles of Association and the Board shall have general authority to make necessary corrections in all the documents wherever it is required to reflect the new name of the company.

Change a company name by special resolution of members The most common way to change a company name is by passing a special resolution of the members, which is simply a formal decision that must be agreed on by at least 75% of members' votes.
