Journal articles frequently have multiple authors. Author names should be listed in the order they appear at the head of the article (not in alphabetical order). In your notes, list up to three authors in full. When there are four or more authors, list only the first, followed by “ et al. ” (Latin for “and others”).

Article in an Online-only Scholarly Journal. MLA requires a page range for articles that appear in Scholarly Journals. If the journal you are citing appears exclusively in an online format (i.e. there is no corresponding print publication) that does not make use of page numbers, indicate the URL or other location information.

APA is used when citing sources for academic articles such as journals, and is intended to help readers better comprehend content, and to avoid language bias wherever possible. The APA style (or APA format) is now in its 7th edition, and provides citation style guides for virtually any type

Start by listing the author's last name and first initials, followed by the date of publication in parentheses. Provide the title of the article, but only capitalize the first letter of the title. Next, list the journal or periodical and volume number in italics, followed by the issue number in parentheses.

Finally, when quoting a journal article directly, include a page number in citations. For instance, we could write: Such decisions are often “based on short-term thinking” (2: p. 186). Here, we’re citing page 186 of the second source in the

Cite by listing the article's author, putting the title of the article in quotations marks, and italicizing the periodical title. Follow with the date of publication. Remember to abbreviate the month. The basic format is as follows:
